THE LAND CONSERVANCY ALSO BUYS PROPERTIES IN FEE TITLE AND RECEIVES GIFTS/DONATIONS OF LAND. THE PROGRAM FOCUSES ON PROTECTING LANDS IN SAN LUIS OBISPO COUNTY WITH IMPORTANT SCENIC, AGRICULTURAL, HABITAT AND CULTURAL VALUES. THE LAND CONSERVANCY STAFF PREPARE GRANT APPLICATIONS AND PROPOSALS, DRAFT AGREEMENTS, IDENTIFY LAND MANAGEMENT GOALS AND OBJECTIVES, AND CONDUCT MONITORING OF EACH PROPERTY ON AN ANNUAL BASIS. THE CONSERVANCY HAS PROTECTED 61,846 ACRES TO-DATE THROUGH EASEMENT FEE TITLE CONSERVATION.

THE ENGAGEMENT AND VOLUNTEER SUPPORT PROGRAM FOCUSES ON ENGAGING COMMUNITY MEMBERS IN THE MISSION OF THE ORGANIZATION AND EDUCATING THE PUBLIC ABOUT NATURE AND LOCAL AGRICULTURE IN SAN LUIS OBISPO COUNTY. THE PROGRAM WORKS TO BUILD SUPPORT FOR THE ORGANIZATION THROUGH COLLABORATIVE PARTNERSHIPS, VOLUNTEER ACTIVITIES, EDUCATIONAL EVENTS, AND OUTREACH OPPORTUNITIES THROUGHOUT THE COUNTY. CURRENTLY THE ORGANIZATION HAS 1,310 HOUSEHOLD MEMBERSHIPS (NON-VOTING) AND 152 BUSINESS MEMBERS (NON-VOTING).
